It is common for parents to request the addresses and phone numbers of campers in their child's group or bus for birthday parties and other such events. Please check this box if you do not want this information to be given out .

School may terminate contract if tuition is not paid in full. Service will be suspended and deposit will not be refunded. 1½% per month late charge (after May 1st) will be added to past due accounts. In the event of delinquent payment, parent agrees to pay all legal fees (equal to the greater of \$300 or 1/3 of the delinquent amount plus interest) and costs incurred during collection process.

REFUND POLICY: Except for a \$50 per child service fee, deposits are refundable for any reason until May 1st. After May 1, NO refund, reduction or allowance will be made for absences, late starts, early withdrawal, dismissal for cause, or acts of God. The only exception is if a child does not adjust by the end of the first week, there will be a pro-rate charge for one week only.

Parent consents to child taking supervised trips as part of summer program. For the safety and general welfare of all campers, the camp reserves the unrestricted right to dismiss a camper whose conduct or influence, in the opinion of the director, is inimical to the best interest of the camp. It is understood that all photography and video taken by camp may be used for promotional purposes. In the event that parent cannot be reached by phone, parent gives permission to medical professional to administer emergency treatment to child. It is agreed that any dispute concerning, relating, arising out of or referring to the subject matter of this contract shall be resolved exclusively by binding arbitration in Nassau County, New York according to the then existing commercial rules of the American Arbitration Association and the substantive laws of that state.

In accordance with NYS regulations, parents of campers with physical or developmental disabilities should inform the camp of such prior to the start of camp. Please note that in most cases, the term developmental disability does not apply to children with ADD, ADHD, learning disabilities or similar conditions.

Merrick Woods is licensed by the New York Department of Health and, as such, is required to be inspected twice yearly. Inspection reports are filed at Nassau County Department of Health, Office of Recreational Facilities, Children's Camps, 200 County Seat Drive, Mineola NY 11501.
